The first appeared in Songs of Innocence in 1789, while a second poem, also called 'The Chimney Sweeper' was included in Songs of Experience in 1794. Like Tom Dacre of the earlier poem, the chimney sweeper is crying. When asked where his parents are, he replies, "They are both gone up to church to pray." The boy goes on to explain that his appearance of happiness has led his parents into believing that they have done no harm in finding him work as a chimney sweep, but the boy knows better.

By comparing Blake's two 'Chimney Sweeper' poems, we can get some sense of his feelings about innocence and experience as 'contrary states'. The sweep in Innocence doesn't understand the life in which he finds himself. He is sold 'while yet [his] tongue, / Could scarcely cry weep weep, weep weep'.

Really, it's a messy business, and in the late 18th century, when Blake was at the peak of his poetry prowess, chimney-sweeping was tantamount to a slave trade. Blake was so disgusted with the whole chimney-sweeping industry that he wrote not one but two poems about it.
