Businesses and Self Employed. You can file Form W-7, Application for IRS Individual Taxpayer Identification Number (ITIN), with your federal income tax return. You must also include original documentation or certified copies from the issuing agency to prove identity and foreign status. If you qualify for an exception, then file Form W-7 with your proof of identity and foreign status documents and supporting documentation for the exception.

Instructions for Form W-7 (Rev. September 2019)

These documents will be accepted. A notarized document is one that the taxpayer provides to a public notary who bears witness to the signing of the official document and affixes a seal assuring that the document is legitimate. These documents will not be accepted for ITIN applications.

Itin Application Supporting Documents

A non-citizen who has to file a federal tax return or a tax reporting document and does not qualify for an SSN should prepare an ITIN number application to get the ITIN number. ITIN is often given to individuals who have to pay U.S. taxes but are not eligible for a social security number.

Use the latest revision of Form W-7. Application for IRS IndividualTaxpayer Identification Number to apply. Attach a valid federal income tax return, unless you qualify for an exception,and include your original proof of identity or copies certified by issuingagency and foreign status documents.

Verify that all information is accurate and matches your supporting documentation. Complete the W-7 form through the Online Application. Include your original federal tax return (s) for which the ITIN is required. Attach the W-7 PDF we send to you via e-mail, to the front of your tax return

Step by Step Instructions - Itin w7 Application

It may take 8-10 weeks before the ITIN is issued. All original documents submitted as part of the application packet should return to the mailing address listed on the ITIN W-7 Form within 60 days of application processing. Required Supporting Documentation For W-7 ITIN Applications A valid, current and unexpired passport is the only stand-alone documentation accepted to prove both your identity and current foreign status. All supporting documents submitted must be unedited original documents or issuing agency certified copies.

New / Replacement Social Security Card Application

In order to submit an application for renewal of ITIN, you need: Form W-7. Make sure to select the reason why you need ITIN, as per Form W-7 instructions. Original identification documents or certified copies by the issuing agency.

ITIN - Individual Taxpayer Identification Number

To renew an expiring ITIN, send a completed Form W-7, Application for IRS Individual Taxpayer Identification Number and required identification documents to the IRS. If you received a CP48 or Letter 5821, attach it to the renewal when you submit the ITIN renewal application.
